

சிட்ட யூனியன் வங்கியின் நிகர வாயம் ரூ. 760 கோடி

நிர்வாக இயக்குனர் என்.காமகோடி தகவல்

சென்னை, மே 28- சிட்ட யூனியன் வங்கியின் கடந்த நிதியாண்டிற்கான (2021-22) வருடாந்திர கணக்கு முடிவுகளை நிர்வாக இயக்குனர் மற்றும் முதன்மை செயல் அதிகாரி என்.காமகோடி வெளியிட்டார். அப்போது வங்கியின் நிகர வாயம் ரூ.760 கோடி உயர்ந்துள்ளது என்று பெருமையுடன் தெரிவித்தார்.

அந்த அறிக்கையில் அவர் கூறியிருப்பதாவது: வங்கியின் மொத்த வர்த்தகம் கடந்த நிதியாண்டில் 9% உயர்ந்து ரூ.88,846 கோடியாக அதிகரித்துள்ளது. வைப்புக்கோடி 7% உயர்ந்து ரூ.47,690 கோடியாகவும், கடன்கள் கடந்த ஆண்டை விட 11% உயர்ந்து ரூ.41,156 கோடியாகவும் உள்ளது. வங்கியின் மொத்த வாயம் 9 சதவீதம் உயர்ந்து ரூ.1,595 கோடியாக உயர்ந்துள்ளது. அதே சமயம் வங்கியின் நிகர வாயம் 28 சதவீதம் அதிகரித்து ரூ.760 கோடியாக



உயர்ந்துள்ளது. வங்கியின் நிகர வட்டி வருமானம் சென்ற ஆண்டை விட 5% உயர்ந்து ரூ.1,916 கோடியாக உயர்ந்துள்ளது. வங்கியின் நிகர உற்பித்தல் கடந்த ஆண்டில் இருந்த மதிப்பான ரூ.5,799 கோடியில் இருந்து உயர்ந்து ரூ.6,550 கோடியாக உயர்ந்துள்ளது. மொத்த வராகக்கடன் 4.70% ஆகவும், நிகர வரா கடன் 2.95% ஆகவும் உள்ளது.

மூலதன விகிதம் 20.85% ஆக உள்ளது. மேலும் 202122ம் நிதியாண்டில் யுபிஇ 123 மூலம் சார்பான மற்றும் ஆண்ட்ராபுட் மொபைல் மூலம் இணையவசதி இல்லாமலே பண பரிமாற்றம் செய்யும் வசதி, வங்கி கிளையை அணுகாமலேயே ஏற்படுத்தி மாற்றம் இறக்குமதி விற்பனைப்புகளை இணையதள வங்கி சேவை மூலம் சமரிப்பிக்கும் வசதி, வங்கி வாயிடாக்காவே நேரடியாக கிரடிட் கார்டு வழங்கும் வசதி, வாடிக்கையாளர்கள் மொபைல் வங்கி சேவை மூலம் புதிய நடப்பு கணக்குகளை விடயோ அழைப்பின் மூலம் சில நிமிடங்களிலேயே துவங்கும் வசதி, காணொலி மூலம் அத்தகான ஆவணங்களை செயலியின் வீடியோவில் காட்டி சில நிமிடங்களிலேயே விட்டிலிருந்தே வங்கி கணக்கு துவக்க முடியும். இவ்வாறு அவர் கூறினார்.
